TEACHER/PARENT INFORMATION SESSIONS

Information sessions will be held in the week commencing Monday 27 February. This is a general information meeting where you can learn about the types of learning and activities that your child will engage in during the year. Individual Teacher/Parent interviews will be held in Term 2. Another note will be sent home next week with details.

MOVING INTO YEAR 7

The department has digitised the Year 6 to Year 7 transition process. In 2023 parents and carers can go online to complete the Expression of Interest (EOI) and Placement not required (PNR) details. EOI and PNR forms will be available on the enrolment page of Fairfield West Public School from **6 March – 31 March**. Information about the process will continue to be shared in our newsletter during the year. If you have questions or would like to speak about this process, please contact the school.

Attendance

Regular attendance at school is mandatory in NSW Schools. As a parent/caregiver, it is your responsibility to ensure that your child/children attend school every day that it is open, unless sick or due to some unforeseeable circumstance. Students need to be at school on time, ready to start the school day. Gates open at 8.30am and students are required to be on site by 8.50am. All absences and tardiness need to be explained within 7 days. Please read the attached flyer as a matter of importance.

Students immunocompromised

To protect the health of the students, staff and school community, please let the school know if your child has contracted an infectious disease, such as COVID-19, chickenpox or any other similar illness. Thank you for your cooperation, as there are several immunocompromised people at Fairfield West PS, and we want to support all the best we can.

RAT KITS

Another set of RAT kits have been sent home. Once again, please keep these in a secure place and use as needed but especially if students have any COVID like symptoms.

UNWELL AT SCHOOL

Any student or staff member who is unwell and/or displays symptoms of COVID-19 will be asked to go home until symptoms no longer exist. It is strongly recommended that they complete a RAT or PCR test.

- If symptoms continue, they should stay at home and take another RAT in 24 hours or have a PCR test.
- If the second RAT or initial PCR test result is negative and they are displaying no symptoms OR another diagnosis is confirmed such as hay fever, the student or staff member can return to school.
- In NSW, positive COVID-19 cases are allowed to leave self-isolation as long as they do not have COVID-19 symptoms.

GATE TIMES

The school gates are automated for student safety. They are open **8.30am-9.10am and 2.50pm-3.10pm.** If you would like to enter the premises during the day when the gates are closed, please press the buzzer at the main gate on Palmerston Road (Cumberland Hwy) and you will be let in to come to the office for assistance. If for any reason you cannot drop off or pick your child up on the agreed times, please contact the front office. Children **should not** be standing outside the school gates for significant lengths of time prior to 8:30am.

Drop Offs are straight forward. On arrival from as close to 8:45am as possible, students come in via the gate they normally enter the school.

School ends at 3.00pm and students need to be collected promptly at 3.00pm. Families are asked to ensure they are at school to collect their child(ren) on time. Staff often have professional learning or meetings after school. Thank you for your cooperation.

IMPORTANT Asthma information- MUST BE DONE EACH YEAR**********

Parents and caregivers need to provide information from their child's medical practitioner **EACH YEAR** including an Asthma Action Plan. The plan must be signed by your child's doctor. You will also need to supply an inhaler for use at school. The Action Plan for asthma is to be followed if the student has an asthma attack at school or to prevent an attack. If your child has an asthma plan, it is important to let us know.

IMPORTANT Anaphylaxis information- MUST BE DONE EACH YEAR*********

Parents and caregivers need to provide information from their child's medical practitioner EACH YEAR including an ASCIA Anaphylaxis Action Plan. The plan must be signed by your child's doctor. You will also need to supply an adrenaline auto-injector for use at school. The ASCIA action plan for anaphylaxis is to be followed if the student has an anaphylactic reaction at school. Please find the link below to assist you: if your child is diagnosed at risk of a severe allergic reaction, particularly anaphylaxis, the Anaphylaxis Procedures contain information designed to minimise the risk to students. KR enjoy participating in hands on play each morning where they are given the chance to develop their social skills and make new friends.











Compulsory school attendance

Information for parents

Education for your child is important and regular attendance at school is essential for your child to achieve their educational best and increase their career and life options. NSW public schools work in partnership with parents to encourage and support regular attendance of children and young people. When your child attends school every day, learning becomes easier and your child will build and maintain friendships with other children.

What are my Legal responsibilities?

Education in New South Wales is compulsory for all children between the ages of six years and below the minimum school leaving age of 17 years. The Education Act 1990 requires that parents ensure their children of compulsory school age are enrolled at, and regularly attend school, or, are registered with the NSW Education and Standards Authority for home schooling.

Once enrolled, children are required to attend school each day it is open for students.

The Importance of arriving on time

Arriving at school and class on time:

- Ensures that students do not miss out on important learning activities scheduled early in the day
- Helps students learn the importance of punctuality and routine
- · Give students time to greet their friends before class
- Reduces classroom disruption

Lateness is recorded as a partial absence and must be explained by parents.

What if my child has to be away from school?

On occasion, your child may need to be absent from school. Justified reasons for student absences may include:

- being sick, or having an infectious disease
- having an unavoidable medical appointment
- being required to attend a recognised religious holiday
- exceptional or urgent family circumstance (e.g. attending a funeral)



Attendance

Following an absence from school you must ensure that within 7 days you provide your child's school with a verbal or written explanation for the absence. However, if the school has not received an explanation from you within 2 days, the school may contact you to discuss the absence.

Principals may decline to accept an explanation that you have provided if they do not believe the absence is in the best interest of your child. In these circumstances your child's absence would be recorded as unjustified. When this happens the principal will discuss their decision with you and the reasons why.

Principals may request medical certificates or other documentation when frequent or long term absences are explained as being due to illness. Principals may also seek parental permission to speak with medical specialists to obtain information to collaboratively develop a health care plan to support your child. If the request is denied, the principal can record the absences as unjustified.

Travel

Families are encouraged to travel during school holidays. If travel during school term is necessary, discuss this with your child's school principal. An Application for Extended Leave may need to be completed. Absences relating to travel will be marked as leave on the roll and therefore contribute to your child's total absences for the year.

In some circumstances students may be eligible to enrol in distance education for travel periods over 50 school days. This should be discussed with your child's school principal.

My child won't go to school what should I do?

You should contact the principal as soon as possible to discuss the issue and ask for help. Strategies to help improve attendance may include a referral to the school's learning and support team or linking your child with appropriate support networks. The principal may seek further support from the Home School Liaison Program to develop an Attendance Improvement Plan.

What might happen if my child continues to have unacceptable absences?

It is important to understand that the Department of Education may be required to take further action where children of compulsory school age have recurring numbers of unexplained or unjustified absences from school. Some of the following actions may be undertaken:

Compulsory Schooling Conferences

You may be asked, along with your child, to attend a Compulsory Schooling Conference. The conference will help to identify the supports your child may need to have in place so they attend school regularly. The school, parents and agencies will work together to develop an agreed plan (known as Undertakings) to support your child's attendance at school.

 Application to the Children's Court – Compulsory Schooling Order

If your child's attendance at school remains unsatisfactory the Department may apply to the Children's Court for a Compulsory Schooling Order. The Children's Court magistrate may order a Compulsory Schooling Conference to be convened.

• Prosecution in the Local Court

School and Department staff remain committed to working in partnership with you to address the issues which are preventing your child's full participation at school. In circumstances where a breach of compulsory schooling orders occurs further action may be taken against a parent in the Local Court. The result of court action can be the imposition of a community service order or a fine.

What age can my child leave school?

All New South Wales students must complete Year 10 or its equivalent. After Year 10, and up until they reach 17 years of age, there are a range of flexible options for students to complete their schooling.

Working in Partnership

The NSW Department of Education recognises that working collaboratively with students and their families is the best way to support the regular attendance of students at school.

We look forward to working in partnership with you to support your child to fulfil their life opportunities.

Dropping and collecting students on the Cumberland Highway – PLEASE ACT RESPONSIBLY

All road rules apply when you are dropping off and collecting your child/children on the Cumberland Highway, so please adhere to the following rules to keep everyone safe. If you do not comply with the following road rules the police may issue you with a hefty fine.

General parking rules

You must not stop your vehicle (that is, bring it to a stop and either stay with the vehicle or leave it parked) in the following circumstances:

- Double parked (that is on the road alongside a car that is parked)
- Between BUS STOP, BUS ZONE, TAXI STAND or TAXI ZONE signs

<u>No parking</u>

You must not stop for more than two minutes in a No Parking area. You must remain in or within 3 metres of the vehicle.

Hours of operations may apply to some signs. This means restrictions apply for those times only. Mobility Parking Permit holders are allowed to park for up to 5 minutes in a No Parking area.

Bus zone - CARS CANNOT STOP in the Bus Zone

This sign means that you are <u>not allowed</u> to stop your vehicle within the direction of the arrow or arrows unless you are driving a bus.

Loading zone

Only drivers of vehicles principally constructed for carrying goods may park their vehicle in a loading zone.

These vehicles may stop for up to 30 minutes if they are being loaded or unloaded.

A station wagon or a three-wheeled goods vehicle may stop for up to 15 minutes.

If you are driving any other sort of vehicle you may only stop to pick up or set down passengers at the kerb.

Hours of operation may apply to some signs. This means restrictions apply for those times only.
